# **TOPICS & SPEAKERS**

### **Proper Prescribing - The Appropriate Management of Opioid Therapy**

#### Dennis James Carter, D.O.

Dr. Dennis Carter graduated from Oklahoma State University Center for Health Sciences and is boardcertified in Osteopathic Family Practice. He is a dedicated physician with over three decades of experience in osteopathic medicine. He is currently employed at the Family Medical Center in Poteau, OK, and at Heavener Nursing Home, where he has been instrumental in providing compassionate care to patients. He is also an Adjunct Associate Professor of Family Practice at Oklahoma State University College for Health Sciences. His extensive career includes various leadership roles, such as Medical Director for several different kinds of healthcare agencies and facilities. Dr. Carter is a respected member of professional associations. including the American Osteopathic Association and the Oklahoma Osteopathic Association, where he has served on the Board of Trustees and as President. He is currently serving a second term as a Board Member with the Oklahoma State Board of Osteopathic Examiners. Dr. Carter's commitment to excellence in medicine and education makes him a valuable asset to the healthcare community.

#### **Approach to Obesity in Children and Adolescents**

#### Paul Dasari, M.D.

Dr. Paul Dasari, M.D., M.P.H., is a board-certified pediatrician and pediatric endocrinologist at the Oklahoma City Indian Clinic. He completed his medical education at Gandhi Medical College, India, followed by a Masters in Public Health from the University of North Texas. Dr. Dasari underwent his pediatric residency and pediatric endocrinology fellowship at the Oklahoma University Health Sciences Center. He is a member of several professional societies, including the Pediatric Endocrine Society and the American Academy of Pediatrics. Dr. Dasari has received numerous awards for his work, including the Best Outpatient Intern of the Year and the Outstanding Resident Teaching Award. He has published several research papers and has been involved in various grants and teaching activities throughout his career.

### American Indian Health Equity & Workforce Development

#### Donald Warne, M.D., M.P.H.

Dr. Donald K. Warne, MD, MPH, is a renowned expert in Indigenous health research, academics, and education, serving as the Provost Fellow for Indigenous Health Policy and Co-Director of the Center for Indigenous Health at the Bloomberg School of Public Health, Johns Hopkins University. He holds a Doctor of Medicine from Stanford University School of Medicine, a Master of Public Health from Harvard School of Public Health, and a Bachelor of Science in Kinesiology from Arizona State University. Dr. Warne has received numerous awards and recognitions for his work, including developing the nation's first Master of Public Health with an American Indian Public Health specialization and the world's first PhD in Indigenous Health. He has over 50 peerreviewed publications, has presented extensively both nationally and internationally, and has secured grants totaling over \$25 million.

### Addressing Health Inequality in Pediatric Cancer: Measurement Strategies and Practical Solutions

#### I-Chan Huang, Ph.D.

Dr. I-Chan Huang, Ph.D., is a Full Member of the Department of Epidemiology & Cancer Control at St. Jude Children's Research Hospital in Memphis, Tennessee. With a background in health services research, Dr. Huang specializes in patient-reported outcomes (PROs) measurement and clinical application, focusing on pediatric medicine. He has led numerous research projects and received prestigious grants, including an NIH/NICHD K23 grant and NIH/NIAMS-funded U01 and U19 grants. Dr. Huang has published over 140 peer-reviewed manuscripts and presented extensively at international conferences. He has served on the board of the International Society for Quality-of-Life Research and is the Founding Chair of the Health Equity Working Group of the Cancer Control & Survivorship Program (CCSP) at NCI-designated St. Jude Comprehensive Cancer Center.

#### Bradley Anderson, D.O.

Dr. Bradley Anderson is an accomplished internal medicine physician currently serving as Associate Professor of Internal Medicine and Medical Director of Virtual Care at Oklahoma State University Center of Health Sciences. He earned his Doctor of Osteopathic Medicine from Campbell University School of Osteopathic Medicine and is working on his Master's in Healthcare Administration from Oklahoma State University. Dr. Anderson is board certified by the American Osteopathic Board of Internal Medicine and is licensed in Oklahoma and Missouri. With a focus on education, he mentors residents and medical students while providing highquality medical care. Dr. Anderson's expertise includes ICU medicine, outpatient procedures, and leadership in multidisciplinary healthcare teams.

#### Mason Two Crow, D.O.
